IT IS ALSO EXPRESSLY UNDERSTOOD AND AGREED that this assignment constitutes a sale, assignment, conveyance, and transfer of all my property, right, title and interest in and to said books and musical compositions, said copyrights and renewals and extensions of copyrights, and of said rights, claims, demands and causes of action, which I may now have or own as next of kin of Mildred J. Hill and Mary Hill, and as descendant and representative of Archibald Alexander Hill.
