ORDER

This cause coming on to be heard upon the petition of Corinne Dorothy Hill, as Executrix of the Last Will and Testament of William Wallace Hill, deceased, for authority to make settlement of all claims and demands against Hill, Joiner & Co., a corporation organized under the laws of the state of Maine and having its principal place of business in Chicago, Illinois; and it appearing to the court and the court finds from said petition and from the evidence adduced in support thereof that the said William Wallace Hill was, at the time of his death, and had theretofore been ever since about the 1st day of January, 1921, in the employ of said Hill, Joiner & Co. under and in pursuance of a certain written agreement between the said William Wallace Hill and said Hill, Joiner & Co., dated the 1st day of January, A. D. 1921, as amended and extended by a certain supplemental agreement in writing between the said William Wallace Hill and said Hill, Joiner & Co., bearing date the 30th day of December, 1922; that Hill, Joiner & Co. has offered to pay to said Executrix the sum of six thousand dollars (\$6,000) in full payment, satisfaction and discharge of all claims and demands which the said William Wallace Hill had at the time of his death or which said Executrix or any future representative of his estate has, or may hereafter have, against said Hill, Joiner & Co. for or on account of any matter

or thing whatsoever, and particularly all claims and demands under, or arising out of, the said written agreement and supplemental agreement, or either of them; and that it will be to the best interest of the estate of said deceased to accept said offer and to make such settlement;

IT IS THEREFORE ORDERED, ADJUDGED and DECREED by the court that said Corinne Dorothy Hill, as Executrix of the Last Will and Testament of William Wallace Hill, deceased, be, and she hereby is, authorized to accept the sum of six thousand dollars (\$6,000) in full payment, satisfaction and discharge of all claims and demands of said estate against said Hill, Joiner & Co., and, upon the payment of the said sum of six thousand dollars (\$6,000) to her by Hill, Joiner & Co., to release and discharge said Hill, Joiner & Co. from and of all claims and demands, of every kind, nature and description, which the said William Wallace Hill had at the time of his death, or which the said Corinne Dorothy Hill, as Executrix of the Last Will and Testament of William Wallace Hill, deceased, or any future representative of the estate of said William Wallace Hill, deceased, has, or may hereafter have, against said Hill, Joiner & Co. for or on account of any matter or thing whatsoever, and particularly from and of all claims and demands under, or arising out of, the said written agreement and/or supplemental agreement between the said William Wallace Hill and said Hill, Joiner & Co.
