PETITION FOR LETTERS OF ADMINISTRATION
DE BONIS NON WITH WILL ANNEXED AND FOR
DISCHARGE OF ATTORNEY FOR DECEASED
EXECUTRIX

TO THE HONORABLE JOHN F. O'CONNELL, JUDGE OF THE PROBATE
COURT OF COOK COUNTY, ILLINOIS:

Your petitioner, LEO B. LOWENTHAL, whose residence is Chicago, Cook County, Illinois, respectfully represents that WILLIAM WALLACE HILL, late of the County of Cook, State of Illinois, departed this life at Chicago, in the said County of Cook, State of Illinois, on or about the 3rd day of April, A. D. 1923, leaving a last will and testament which has been duly probated and admitted to record in this court; that pursuant to an order of this court entered on the 14th day of May, A. D. 1923, letters on said will were issued to CORINNE DOROTHY HILL, bearing date the 14th day of May, A. D. 1923; that said CORINNE DOROTHY HILL accepted said trust and continued to act as such executrix until the 27th day of September, 1934, on which date she died, leaving the estate of the said WILLIAM WALLACE HILL not fully administered; that the entire real and personal estate of said decedent remaining to be administered will not exceed the sum of \$25.00; that said estate consists solely of a possible one-eighth interest in the copyright and renewal copyright of certain children's

songs and collections and compilations thereof; that your petitioner is informed that there are certain parties willing to purchase said copyrights and to bear such further expense as may be involved in completing the administration of the estate of WILLIAM WALLACE HILL; that there are neither heirs, next of kin, legatees, creditors, within the state qualified to petition this court for the appointment of an administrator de bonis non with will annexed; that your petitioner was attorney for CORINNE DOROTHY HILL during her lifetime, in her capacity as executrix of the estate of WILLIAM WALLACE HILL; that your petitioner has received no fee or compensation for his services as said attorney; that your petitioner, believing that the administration of said estate should be completed, and that he is entitled to compensation for said services, pray that the court will grant letters of administration de bonis non with the will annexed to ALLEN DAVY , who is a resident of the County of Cook, State of Illinois, and whose post office address is Chicago, Cook County, Illinois, upon taking the oath prescribed by the statute and upon entering into bond in such sum and with such security as will be approved by the court; that your petitioner further prays that an order be entered herein authorizing your petitioner to withdraw as attorney for said CORINNE DOROTHY HILL in her capacity as Executrix of the estate of WILLIAM WALLACE HILL and discharging him from further duties as such attorney.
